Sub: Grant of conditional permission to the Glocal Unani Medical College & Hospital and Research Centre, Village Ali Akbarpur, Mirzapur Pole, Tehsil-Behat, Distt. Saharanpur, Uttar Pradesh with 60 seats (instead of 100 seats) in UG (BUMS) course under Section 13C/13A of the IMCC Act, 1970 for the academic session 2018-19- reg.

Sir/Madam,

I am directed to refer to the Ministry's order no. R.12012/03/2015-EP (IM-1) for 2017-18 dated 11.09.2017 related to admission matter for the year 2017-18 intimating certain shortcomings for rectification for consideration of the case for the 2018-19 session.

2. The CCIM had carried out an inspection of the institution on 07.02.2018 and re-visited on 21-22.05.2018 to reassess the available facilities of teaching and practical training as well as to verify the compliance submitted by the college and forwarded its recommendations and report to the Ministry. On examining the same, it was observed that there was shortage of teaching staff and hospital staff. Bank transaction in respect of salary register was not shown to visitors. Number of species in Herbal garden was only 50 against the requirement of 150 species. Availability of equipment and instruments was less than 75% in Saidla Lab, Pharmacognosy lab, OT-Eye & ENT. Web based computerised central registration system, X-Ray, ECG and USG and Aadhaar based Geo location enabled attendance system were not available. The college was also not meeting the requirement of minimum constructed area for Admn. wing, Lecturer halls, Library, tasheerul Ul Badan, Munafeul Aza dept., Ilmul Advia dept., Ilmul Saidla dept., Mahiyatul Amraz dept., Tahaffuji wa samaji tib dept., Amaraz e Atfal dept., Ilaj bit Tadbeer dept., Kulliyat dept. and teaching pharmacy. Therefore, under provisions of the first proviso to sub-section (5) of Section 13A of the IMCC Act, 1970, an opportunity of hearing was granted to the college on 25.08.2018 to present the case.

3. The observation of hearing Committee based on submission made by the college representatives during hearing and recommendations & visitation report of the CCIM have been carefully examined in terms of the "Indian Medicine Central Council (Requirements of Minimum Standard for under-graduate Unani Colleges and attached Hospitals) Regulations, 2016, provisions under the IMCC Act, 1970, relevant regulations made thereunder, and as per approved Standard Operative Procedures (SOPs), it is found that College is fulfilling notified and approved criterion for granting conditional permission for only 60 seats in UG (BUMS) course as recommended by CCIM.

4. It has, therefore, been decided by the Central Government to grant conditional permission to Glocal Unani Medical College & Hospital and Research Centre, Village Ali Akbarpur, Mirzapur Pole, Tehsil-Behat, Disttt. Saharanpur, Uttar Pradesh to take admissions for 60 seats (instead of 100 seats) in UG (BUMS) course for the academic session 2018-19 under section 13C/13A of the IMCC Act, 1970, subject to the condition that the college shall fulfill the following requirements by 31st December, 2018:

- i. Functional Aadhaar based Geo location enabled attendance system for teaching staff, non-teaching staff, and hospital staff.
- ii. Web based computerised central registration system in OPD & IPD in the Hospital.
- iii. USG facility in the Hospital.

5. In addition, following requirements should be fulfilled by the college by 31st December, 2018 to get conditional permission for the session 2019-20:

- (i) all the Requirements of Minimum Standard of infrastructure and teaching & training facilities as specified in Regulation 3 of the "Indian Medicine Central Council (Requirements of Minimum Standard for under-graduate Unani Colleges and attached Hospitals) Regulations, 2016;
- (ii) all the requirements of the Indian Medicine Central Council (Minimum Standards of Education in Indian Medicine) Amendment Regulations, 2016 (for Unani);
- (iii) all the requirements under the provisions of the IMCC Act, 1970 and relevant Regulations made thereunder should be fulfilled *in toto*,

6. The fulfillment of the conditions attached to the permission given above may be made within the time period specified and compliance report should be submitted to the Ministry of AYUSH endorsing a copy to the CCIM also. The CCIM will verify that the conditions have been fulfilled by means of an inspection and submit a report in this matter to the Ministry of AYUSH for considering the permission matter from the academic session 2019-20.
